Eagle Scout Project Proposals are reviewed by appointment, from 6-7pm, before District Round Table (first Thursday of each month at Salvation Army, 5328 24th St E, Bradenton, FL 34203.)

To submit a project for review, please send a signed electronic Eagle Scout Project Proposal to [manateeadvancement@gmail.com](mailto:manateeadvancement@gmail.com) Proposals received will be scheduled at the next available Round Table.

You may not begin your project until you have approval. Once approved, the District Advancement Chair will send you an email with important information and next steps – please read this email carefully!

At the appointment, the Scout's Eagle materials will be reviewed for completeness. In addition to the items above, the Scout's Eagle Scout Reference Forms should be received by the Manatee District Advancement Chair. If all is in order, the Scout's submission will be accepted. The Eagle Scout Rank Application will be passed to the Manatee Advancement Chair and submitted for verification to the Southwest FL Council. The Manatee Advancement Chair will contact the Scout with approval, or any issues that need to be resolved. When this is completed, the Scout will be scheduled for their Eagle Board of Review.

Eagle Boards of Review will be held at Camp Flying Eagle, on the second Saturday of the month, by appointment only. Report to the the Campmaster's Administration Building for the assigned location within CFE. Dates for the first half of 2019 are as follows:

June 8

If you are unable to attend one of the dates above, please contact the Manatee District Advancement Chair. Scouts should plan accordingly to allow enough time to attend one of the Eagle Board of Review dates above. Alternative arrangements will only be granted on an exception basis.
